Subject: - Regular Departmental Action against the then officers/officials of the PHE Division Handwara – Imposition of penalty and treatment of suspension period thereof.

## Government Order No. 156-JK(JSD) of 2025 Dated: - 25.06.2025

- 1. Whereas, the Chief Engineer, PHE Kashmir, vide communication dated 24.04.2014, intimated regarding embezzlement of funds/fraudulent withdrawal of a substantial amount from official Account No. 0131040500015272 maintained with J&K Bank, Handwara, under the NRDWP Scheme; and
- 2. Whereas, a Public Interest Litigation (PIL) No. 16/2014 titled Javid Ahmad Zargar Vs State & Others was filed before the Hon'ble High Court at Srinagar, wherein the petitioner alleged large-scale irregularities and embezzlement amounting to crores of rupees under various schemes, particularly NRDWP, executed since 2006 in PHE Division Handwara, with the connivance of officers/officials then in charge; and
- 3. Whereas, considering the gravity of the matter, the Chief Engineer, PHE Kashmir, vide order dated 24.04.2014, constituted a three-member committee comprising the Superintending Engineer (Mechanical) North, Srinagar (DVO), Chief Accounts Officer, PHE Kashmir, and Technical Officer to Chief Engineer, PHE Kashmir, to thoroughly investigate the allegations and ascertain the facts. After scrutinizing records of PHE Division Handwara, the committee submitted a detailed report recommending, based on prima facie evidence, that the matter be referred to the Crime Branch for investigation. Consequently, FIR No. 91/2014 was registered at P/S Handwara under Sections 467, 468, 420, 409, and 120-B RPC. The case was subsequently transferred to the Crime Branch, Srinagar, on 25.08.2014 by IGP (Technical/CIV), on the department's request; and
- 4. Whereas, the following 22 officers/officials of PHE Division Handwara were placed under suspension in connection with the case and were attached to the office of the Chief Engineer, Irrigation & Flood Control Department, Kashmir:-

- 6. Whereas, the cases of two officials of the Accounts Cadre, namely Shri Gh. Mohammad Dar and Shri Gh. Nabi Ahangar, both then Assistant Accounts Officers, were already referred to the Finance Department for appropriate action; and
- 7. Whereas, vide Government Order No. 411-PW(Hyd) of 2014 dated 29.10.2014, the then I/c Superintending Engineer, Hydraulic Circle Baramulla, was appointed as Inquiry Officer to investigate the matter and submit recommendations. However, he retired on 30.09.2016 without submitting the inquiry report; and
- 8. Whereas, vide Government Order No. 38-PW(Hyd) of 2015 dated 09.02.2015, read with Government Order No. 03-PW(Hyd) of 2016 dated 08.01.2016, a committee was constituted to conduct a detailed inquiry into the charges and determine the exact financial loss to the state exchequer; and
- 9. Whereas, vide Government Order No.134-PW(Hyd) of 2016 dated 20.05.2016, Shri Sushil Aima, then I/c Chief Engineer, Design Directorate (DIQC), Jammu was appointed as Chairman of the Committee constituted under Government Order No. 03-PW(Hyd) of 2016 dated 08.01.2016. Besides, vide Government Order No. 137-PW(Hyd) of 2016 dated 27.05.2016, the then Public Law Officer, PHE, I&FC Department, was appointed as Presenting Officer in the matter related to PIL No. 16/2014 titled Javid Ahmad Zargar V/s State & Ors; and
- 10. Whereas, in the meantime, vide Government Order No. 147-PW(Hyd) of 2016 dated 01.06.2016, a Fact-Finding Enquiry Committee under the convenorship of the then Director Finance, PHE/I&FC, comprising the Chief Engineer, I&FC Kashmir, and Joint Director (P&S), PHE/I&FC, was constituted to conduct an exhaustive enquiry into the functioning of PHE Division Handwara from 2006 onwards, excluding the period under Crime Branch investigation (FIR No. 91/2014), and to identify the officers/officials involved; and
- 11. Whereas, the Committee constituted vide Government Order No. 03-PW(Hyd) of 2016, submitted its report on 01.08.2016, the key findings included:-
  - That there have been deviations/breach of the codal procedure for execution of the works. The same has been established by the findings of the Inquiry Committee appointed by the Chief Engineer, PHE Department Kashmir as also subsequently by the Crime Branch of the State Police with assistance from Finance Department; and
  - That there has been loss to the exchequer by drawls of money without supporting documents and against non-existent works and its diversion through a maze of drawls into the personal saving accounts of the Cashier and some private persons/contractors, which too has been established by the investigation of the Crime Branch of the State Police.
- 12. Whereas, vide Govt. Order No.23-GAD (Vig) of 2016 dated 11.08.2016, issued by the General Administration Department, prosecution was sanctioned against the following accused public servants, then posted in the PHE Division Handwara for commission of the offences punishable under Section 409, 467, 468, 120-B of RPC r/w/ Section 5 (2) of J&K Prevention of Corruption Act, Samvat, 2006 in case FIR No. 91/2014 of Police Station Handwara:-

Whereas, vide this Department's letter dated 29.08.2016, Shri Sushil Aima, the Inquiry Officer was requested to submit a fresh report in compliance with Government Order No. 147-PW(Hyd) of 2016, as the earlier report did not quantify the exact loss or clearly establish the role of each erring officer. However, the then I/c Chief Engineer (Inquiry Officer) retired on superannuation on 31.07.2017 without submitting the revised enquiry report as requested; and
- 14. Whereas, the then Director Finance, PHE/I&FC (Convenor), submitted a fact-finding report on 26.09.2016, recommending a Special Audit by the Director General, Audit & Inspections, J&K, to review each transaction during the period in question and determine accountability; and
- 15. Whereas, vide O.M. dated 27.10.2016, Finance Department was requested to conduct the Special Audit of PHE Division Handwara for the period 2006 to 31.05.2016. In return, Directorate of Audit and Inspections J&K vide letter No. DAI/Per/Spl/611 dated 20.02.2017, Dy. Director (Hqr) Audit & Inspections, J&K Jammu submitted the Special Audit Report which highlighted the irregularities and malfeasance in the execution of Schemes; and
- 16. Whereas, the Crime Branch vide letter dated 12.06.2017, intimated that investigation in FIR No. 91/2014 of P/S Handwara had been concluded, and chargesheet was filed on 29.09.2016 before the Competent Court of Jurisdiction against the following nine accused persons:

- 17. Whereas, the Crime Branch further intimated vide the same communication dated 12.06.2017 that during the investigation, public servants namely Mr. Qazi Mushtaq Ahmad, the then I/c Assistant Executive Engineer, and Mr. Abdul Rehman Shah, the then Assistant Lineman of PHE Division Handwara, were not found to be involved in the commission of any crime, and therefore benefit under Section 169 Cr PC was extended to them; and
- 18. Whereas, vide Government Order No. 192-PW(Hyd) of 2018 dated 27.04.2018, the then I/c Chief Engineer, PHE Kashmir, was appointed as Inquiry Officer and the then I/c Executive Engineer, FBI Division Tangmarg was appointed as Presenting Officer to conduct departmental proceedings against the officials against whom charges had been served in PIL No. 16/2014. However, inquiry report was not submitted as both Inquiry Officer and Presenting Officer retired on superannuation on 31.03.2019 and 30.06.2020 respectively; and



- 19. Whereas, out of the 22 officers/officials involved in the case, the suspension period of Shri Fida Hussain Wazir, the then Executive Engineer, was treated as on duty vide Government Order No. 178-JK(JSD) of 2020 dated 04.09.2020; and
- 20. Whereas, the Hon'ble High Court, vide order dated 19.02.2021 in PIL No. 16/2014 titled Javid Ahmad Zargar Vs State & Ors, disposed of the case along with connected CM(s) and directed the Commissioner/Secretary, Jal Shakti Department (PHE), to conclude departmental proceedings in accordance with the rules and regulations in vogue and pass appropriate orders; and
- 21. Whereas, vide Government Order No. 186-JK(JSD) of 2023 dated 10.08.2023, the intervening period of suspension of the following officers/officials were treated as on duty under Article 108-B of J&K CSR Volume-I:

- Whereas, vide Government Order No. 187-JK(JSD) of 2023 dated 10.08.2023, the then I/c chief Engineer, I&FC Kashmir was appointed as Inquiry Officer to conduct an in-depth inquiry against the following 12 officers/officials of PHE Division Handwara for embezzlement/fraudulent withdrawal of funds from official Account No. 0131040500015272 under the NRDWP Scheme (PIL No. 16/2014):-

- 23. Whereas, the Inquiry Officer submitted the inquiry report vide No. 3430 dated 26.09.2023, with the following observations and recommendations:



The Presenting Officer Mr. Bilal Ahmad Malik, Executive Engineer, PHE Division Handwara have duly presented the case before the Inquiry Officer. Thereafter the Presenting Officer was directed to seek some details/documents/clarification related to case from all the involved Officers/Officials for which all the accused officers and officials were intimated by the Presenting Officer to appear before the Inquiry Officer which they did on 23.08.2023.

While going through presented record and reports of various committees, it is revealed that number of committees have been framed which have carried out in-depth enquiries in the matter after going through all the allegations leveled against the officers/officials and subsequent replies submitted by the officers/Officials. On the basis of enquires, all the officers and official were reinstated by the Government vide different orders with the conditions that their suspension period shall be decide after conclusion of the Departmental proceedings.

After going through the various reports, prime facie it seems that the officers/officials appearing from S. No. 1 to 5 of the Government Order No. 187-JK(JSD) of 2023 dated 10.08.2023 have grossly violated the Government rules and regulations and have drawn huge amount of Rs 1,88,69,048/- unauthorizedly, illegally and undoubtedly with the oblique motives. Regarding the officers/Officials figuring from S.No.6 to S.No.12, it appears that their involvement in the criminal offense has not been established by any of the committees framed for the purpose and as such needs to be exonerated.

The Inquiry Officer has recommended the following course of action against the officers/officials for deciding their suspension periods:-
