 - iii. In case the requirement of the borrowing organizations ceases or the officers deputed by the Jal Shakti Department are repatriated, the junior most officers shall be reverted from the higher posts and shall not have any claim of benefit of assignment of temporary charge of the higher post.
- 3. Till further orders, the officer shall continue to work with the division he is presently posted and shall also hold the additional charge of the post of Junior Engineer at his current place of posting.
